6 . ACCIDENTAL RELEASE MEASURES

Environmental Precautions:

In the event of a major spill, prevent spillage from entering drains or water courses.

Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and sweep granules into a pile and shovel into drums for subsequent disposal. Avoid generating dust. Provide adequate ventilation.

7 . HANDLING AND STORAGE

Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of dust. Food, beverages and tobacco products should not be stored or consumed where this material is in use.
